

In addition to the duties that are designated in the Municipal Code, each member of the Town Council represents the Council and the Town by serving in a number of different local, countywide and regional capacities. These include serving on a variety of commissions, committees and boards to represent Danville.

Councilmembers are appointed to fill these liaison roles annually, following the installation of the new Mayor at the first Town Council meeting in December. While serving in a liaison capacity, Councilmembers attend the scheduled meetings of the commission, committee or board assigned, and report back to brief the Town Council at regularly scheduled public meetings. Where appropriate, the appointed representative brings relevant issues to the full Town Council for input and direction prior to taking action at their assigned commission, committee or board.

The Commission serves on as the primary advisory body to the Town on matters related to cultural and arts facilities and programs for Town residents. <p><b>Association of Bay Area Governments (ABAG) - General Assembly:</b> ABAG is the regional planning agency for the nine counties and 101 cities/towns of the San Francisco Bay region. ABAG is governed by an Executive Board and policy direction from delegates on its General Assembly (consisting of elected officials from each member city/town and county). In addition, the General Assembly adopts the annual budget and work program, and reviews policy actions of the Executive Board. <p><b>Central Contra Costa Transit Authority (CCCTA) or "County Connection":</b> County Connection provides fixed-route and paratransit bus service throughout central Contra Costa (in an area stretching from Martinez to San Ramon, and in Lamorinda). Its Board of Directors consists of 11 members from ten cities and unincorporated central Contra Costa County, and is responsible for all of the policy and financial decisions of the Authority. <p><b>Central Contra Costa Solid Waste Authority (CCCSWA):</b> The Solid Waste Authority provides solid waste and residential recycling services for Contra Costa County and holds franchise agreements with Allied Waste Services for the collection, transfer and disposal of residential and commercial solid waste, and with Valley Waste Management for the collection and marketing of residential recycling, green waste and food scraps. <p><b>Contra Costa Transportation Authority (CCTA):</b> CCTA is a public agency created through Contra Costa voters' approval of the county's 1/2-cent transportation sales tax program in 1988. CCTA oversees the program, facilitate countywide transportation planning, and serves as the county's designated Congestion Management Agency, responsible for putting programs in place to manage traffic congestion. This agency is governed by an 11-member board with representation from each of the regional transportation planning committees (TRANSPLAN, TRANSPAC, WCCTAC, SWAT) and the Contra Costa Mayors Conference. SWAT is a forum for regional transportation planning activities, provides input to CCTA, and oversees subregional programs. <p><b>League of California Cities (the League):</b> The League is an association of California city officials who work together to enhance their knowledge, exchange information, and combine resources to improve and advocate for California municipalities. <p><b>Tri-Valley Affordable Housing Committee (TVAHC):</b> The TVAHC was formed in 1992 to collaborate and expand regional affordable housing opportunities, and ultimately created the Tri-Valley Housing Opportunity Center (TVHOC) as a non-profit homebuyer education center. <p><b>Tri-Valley Convention &amp; Visitors Bureau (TVCVB):</b> The purpose of the TVCVB is to promote tourism in the Tri-Valley. In 2006, the TVCVB formed the Tri-Valley Tourism Business Improvement District (Tri-Valley TBID), which was subsequently extended in 2010, to provide a funding source for regional tourism marketing and promotion efforts. Danville, along with the other four Tri-Valley cities, are within the TBID. <p><b>Tri-Valley Transportation Council (TVTC):</b> The TVTC was formed in 1991 to provide a forum for the review and coordination of planning and construction of transportation facilities in the Tri-Valley. In 1998, it established the a uniform regional impact fee for traffic mitigation, the Tri-Valley Transportation Development Fee (TVTDF) to provide supplemental funding for the implementation of regional transportation projects in the Tri-Valley. The TVTC is governed by a seven member council, consisting of one elected representative from each of the five cities (Danville, San Ramon, Dublin, Pleasanton, Livermore) and from each of the two counties (Alameda and Contra Costa).
